Why The Need For A New System?

- BSA is upgrading their database systems to be more efficient and to save money
- New system will be simpler and easier to use
- It's on the same database as Scoutbook and facilitates data sharing



When Will The New System Become Effective?

- All charters due December 31, 2021 and beyond
- Units can begin processing their charters on October 15th
 - In future years, charter renewal will begin on Oct. 1

- No access codes required
- Same login and password as for Scoutbook
- Access through Internet Advancement
 - [Advancements.scouting.org](https://advancements.scouting.org)
- Uploads for new applications or CBC forms easy to manage
- ALL BSA programs will use the same system
- No paper copies need to be printed or turned into the council Service Center

Who is Responsible For Completing The Charter?

- The Unit Key 3 each have access to charter information
 - Unit Leader, Committee Chair, Charter Rep
- A unit can identify a Key 3 Designate to work charter details
 - A Key 3 Designate can be assigned by a Key 3 member using Organizational Manager in my.scouting (see next slide)

Who Approves The Charter and How?

- The COR will electronically approve the charter
 - A COR must have an email address to approve
 - Another member of the Key 3 can also approve the charter
- For Explorer Posts who do not have a COR, the Executive Lead for the unit can approve the charter



How Does A Unit Complete A Charter If No Internet Access?

- Units can request a paper copy of their charter and manually complete
- Once the charter is completed, it can be turned in to the council Service Center



How Is The Charter Payment Managed?

- A unit has three options
 - Pay online at ‘checkout’ using a credit card
 - Note: There is a fee (3%) for this method
 - Direct bank withdrawal using an ECHECK
 - Note: \$1.00 service processing fee
 - **Submit check directly to the council Scout Service Center**



When Does The Charter Renewal Process Begin?

- Charter Renewals will be available to start October 15
- This is two weeks later than in years past
- Extra time needed to complete system implementation
- A later start date should not be an issue
 - Simpler process than previous Charter Renewal process
 - Most units don't begin charter activity until late October



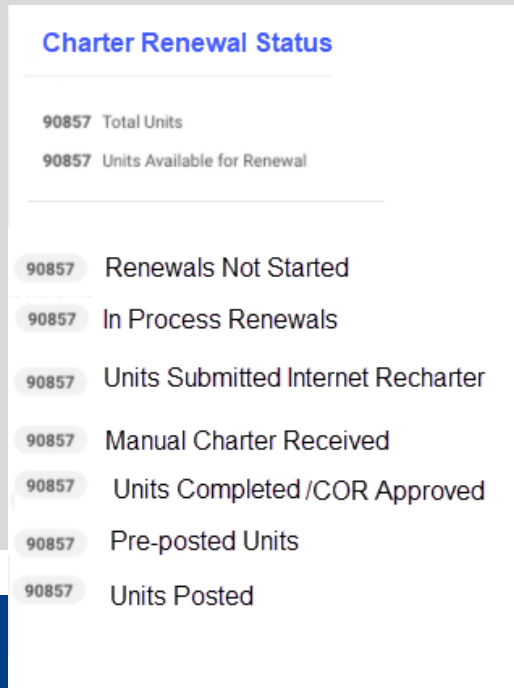
How Can A Commissioner Help A Unit With the Charter Renewal?

- Take the training for the new system
- Schedule time to meet with unit leader and/or committee chair
 - Meet at 75-day point and again as required
- Encourage early start with Roster Update
- Discuss how renewal fees will be managed
- Be sure there is time to get necessary signatures



How Will Commissioners Know How The Unit Is Progressing Through the Charter Process?

- A Charter Renewal Dashboard will be available in Commissioner Tools to view a unit's status
- See example



How Else Can Commissioner's Help?

- Common defects include:
 - New adult without complete application (e.g., criminal background check, YPT, all application sections completed)
 - Current adults with expired YPT
 - Not enough leaders to complete minimum charter requirements
 - Incomplete signatures
- Help the unit to avoid these common defects



Additional Help

- If unit needs additional help
 - Seek advice from commissioner
 - Seek advice/assistance from area professional



Charter & Member Renewal

- Goal: Submit Unit Charter Ontime

- Work collaboratively with unit commissioner to complete your charter
- All charters are due no later than December 1, 2021



National Service Territories Council Performance Standards

1. **Youth Safety**— YPT Threshold of 98% minimum

The Executive Board of the Las Vegas Area Council has adopted a Youth Protection Training standard that every registered adult volunteer and youth participant over the age of 18 must complete Youth Protection training in the current calendar year. Youth Protection Training is required on an annual basis.

Example: In order to recharter for 2022, all adults must have a 2021 YPT completion date.
